Supplementary Regulations

1. Announcement

Venture Bound Members Motoring Club (VBMMC) will organise Quest Tour by Venture Bound, as a one day Touring Assembly on 04 August 2024 starting and finishing at the Piston Club @ The Stag Redhill, Stratford-Upon-Avon. B49 6NQ

2. Jurisdiction

This meeting will be held under the General Regulations of Motorsport UK (incorporating the provisions of the International Sporting Code of the FIA), and these Supplementary Regulations.

3. Permit

The event will be run under a certificate of exemption issued by Motorsport UK. Permit Number: TBA

4. Eligibility

The event is open to anyone – no Club Membership is required. However, VBMMC Elected Members qualify for a £10 Entry Fee discount. You can join as a VBMMC Member through the following link: <https://www.venturebound.co.uk/members>

The event is open to any road legal car in order to promote this discipline. Each car must have a Driver and a Passenger. All cars must hold a Valid V5 Certificate, be taxed, and have a current MOT (If applicable). Drivers will be required to sign a disclaimer prior to starting the event to confirm:

- I. Driver has a Valid Driving Licence (Competition Licence are not required/applicable).
- II. The vehicle they are driving is Insured, Taxed and has a valid MOT (vehicle is road worthy/legal).

5. Scrutineering

As this event is run under a Touring Assembly Permit and there is no timed competition Scrutineering is not applicable.

6. Event Start

The event will start at 10:00 on Sunday 4th August 2024. Cars will depart at approximately one-minute intervals. Cars will start in order of age with the oldest car starting first. Start Times will be notified one week prior to the start of the event by e mail. Crews are advised to arrive at least 40 mins prior to their allocated start time or earlier to enjoy the tea and coffee.

Electronic signing on will be used on this event. Crews will sign on at the start of their adventure using the app. Any crew not signed on by 10:00 on the 4th August will be deemed to have not started.

7. Description of Event

The event will be 70 miles long

Navigation will be through an App on a Smart Phone. Crews will have the option to take part in Quest Drives along the route. What is a Quest Drive

With a social gathering in the morning at The Piston Club @ The Stag for teas and coffee. We embark on our scenic tour around mid morning. This is a relaxed event with interesting places to visit such as The Cotswolds Distillery and Hook Norton. Navigating from your smart phone or tablet, you follow the GPS back to The Piston Club for afternoon refreshments and a social before heading home early evening.

To be registered as a finisher, crews must return to the finish venue by 16:00.

8. Identification

Crews will be issued with a rally plate once their basic safety check has been completed. The plate must be mounted on the front of vehicle, facing forwards.

9. Entries

The maximum entry for the meeting is 75 and the minimum is 10. Should any of the above figures not be reached, the organisers have the right to adjust or cancel the event.

The entry list opens on publication of these regulations and closes finally on 31st July 2024 at 23:59 or when the Entry List is full. A reserved list will be opened should the entry list fill early.
